## WHAT DOES PRIMERICA DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal and state laws give consumers the right to limit some but not all sharing. These laws also require us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

Examples of the personal information we collect and may share depend on the product or service you have with us. This information can include:

- Social Security number and checking account or credit card information
- Transaction history and medical information
- Driver's license number and contact information

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Primerica, including our Representatives, chooses to share; and whether you can limit this sharing.

How does Primerica protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with the law. These measures include computer safeguards and secured files and buildings.

How does Primerica collect my personal information?	<p>We collect your personal information, from these sources:</p> <ul style="list-style-type: none"> <li>• From you: on product applications, etc.</li> <li>• From our affiliates and our Representatives: transaction information</li> <li>• From others you authorize: account rollovers, medical reports, consumer reports, etc.</li> </ul>

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See "Other Important Information" below for more on your rights under state law.</p>

**Definitions**

<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Our affiliates are the companies listed above in "Who We Are."</i></li> </ul>

<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Nonaffiliates we share with can include our independent contractor Representatives, insurance companies, lenders, mutual fund companies and service providers.</i></li> </ul>

<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>Primerica doesn't share with its joint marketing partners.</i></li> </ul>

## Other Important Information

When you apply for insurance, we collect data from Insurance Support Organizations that may retain and disclose the same data to others.

If you have applied for a policy, insurance law in your state may provide you additional rights: You have the right to see and copy the personal information that we have about you. You also have the right to ask us to correct, amend or delete any information about you that you believe to be incorrect and we will respond within 30 days. If the information should be corrected, we will update our files and send the correction to anyone who received the incorrect information in the last two years. If we do not agree that the information is incorrect, you have the right to give us a statement of what you believe to be the correct information, which we will place in your file and send to anyone who received or will receive the original information.

However, we will not send you any medical information we have received about you from a doctor or other health care provider. Instead, you should contact the provider directly to obtain the information you seek. In addition, information collected in connection with, or in reasonable anticipation of, a claim or civil or criminal proceeding, is not subject to the rights described above.

### **Nevada Residents**

State law in Nevada requires we explain that you may ask to add your telephone number to our internal “Do Not Call” list. Primerica representatives and employees are prohibited from calling telephone numbers listed on our internal “Do Not Call” list for solicitation purposes. You may still receive calls that are not solicitations.
